- 3. Approval of Minutes of March 18, 2018 Board of Directors Meeting
- 4. Commodore's Report Danny North noted that the class is in good shape financially and organizationally. We still need to work on ways to streamline the measurement processes. Future championship dates and venues need to be confirmed.
- 5. Treasurer's Report On behalf of treasurer, Nicki Majernik, Sherri presented the financial statements (see attached) as of July 31, 2018. She noted that dues income is running consistent with prior years and that current year overall income and expenses are expected to be on budget. The purchase of the five year

supply of Sabot II trophies was completed earlier in the year. The stock is stored in the class office and will be expensed annually as appropriate.

6. Office Report – Sherri reported that the new online membership system is working well and will be even smoother next year as members are used to the process. The current membership stands at 373 with a target of matching or exceeding the 2017 final membership of 394.

She suggested a reduction in the number of take home trophies for the Senior Sabot Nationals, noting that in 2018 the class spent \$885 on trophies which was only offset by \$420 in host fees to the class. <u>The group agreed that this reduction is appropriate and directed Sherri to write up the new language for the necessary change to the Senior/Master/Clydesdale Championship Regatta trophy section in the Class Rules.</u>

7. Chief Measurer's Report – Tom Dessel presented his written report (see attached).

He added the suggestion that in the future, only new sails should be measured and any sail already with an official INSA stamp would be considered as approved.

He noted that in future further clarification is needed regarding the language for the attachment of hull corrector weights, types of weights allowed for skipper correction weights and the placement of those weights. The Rules Committee was tasked with follow up on this item.

Tom noted that there are some boats (Restoration Hardware boats, etc) still to be measured for certification. He will provide an update on those at a later date.

Open discussion followed on the interpretation of the $\frac{1}{4}$ " maximum movement allowed at the bottom of the mast tube. Chris Busch noted that this was an issue for many during the lead up measurement to 2018 Junior National. Tom Dessel added that the problem was typically where further modification had been done to the tube making the movement large than the $\frac{1}{4}$ " allowed. The group agreed that the language in the current yacht specifications does not need to be changed.

A question about struts was referred to the Measurement Committee for further investigation.

- **8. a.** Race Committee Randy Smith was on the water running the Junior Nationals. He will be asked to provide a follow up report. Sherri noted that he has provided templates for the NOR and SI for the class championships making it easier for the hosts of our championships.

Measurement Equipment:

- Aluminum blade template #1, #2, #3, #4 #4 has been assigned to the INSA office.
- Hull template [5 parts] #1, #2, #3, #4 #4 to be assigned to the INSA office.
- Scales [2 digital] Require minor modification.

Junior Sabot Nationals 2018 - LBYC

- Measured 145 boats & gear at six various venues.
- Qualified entries -120 boats & skippers
- Sails measured & INSA stamp on all sails.
- Mast can lower attachment pin forward & aft movement not-allowed.
- Substitution of a different boat during measurement w/ no prior notice.

INSA – Measurement / Inspection Items:

- Fixed corrector weight attachment method Point of attachment bonded to hull.
- Skipper corrector weight location / Attachment method
- Mast step bolts in aluminum frame must be secure no movement.
- Mast tube modification for forward/aft movement not-allowed.
- Bilge pump installation Noted on inspection form.
- Stern thwart size/material/thickness Conforms to stern thwart specifications
- USCG PFD Conform to the specification or allow non-USCG
- Hull number in the boat method of marking so it is clear view.
- Mast wood / aluminum /composite Type of material noted on inspection form.
- Boom wood/aluminum/composite Type of material noted on inspection form.
- Mast maximum clearance O.D. of the mast to the mast can I.D. / spacer or sleeve.
