Proposal regarding a modification to "Article XII – Amendments" in the INSA By-laws.

Background:

This proposal is designed to ensure that the Naples Sabot retains its identity and approaches significant change in a methodical manner. Small changes to the rules (i.e. minor changes in verbiage, small changes that have little to no effect to on the water performance, etc.) would continue to follow the current procedure. This proposal targets changes that can lead to significant changes in the performance of the boat and should be properly discussed and investigated in an effort to ensure that a fair and equitable implementation of the new rule occurs.

The changes to the text of the by-laws are in red. The flow chart is also included with the proposal.

ARTICLE XII - Amendments

2. Specifications and Rules Official specifications of the Naples Sabot yacht design and dimensions, and rules of the Association, may be amended by a two-thirds vote of the Board of Directors.
